All participating dogs will be given a critique of their herding instinct by the Tester. All qualifying dogs will receive a Herding Instinct Certificate.

1. Participants will be responsible for picking up after their dogs.
2. There is limited shade. Participants are advised to bring their own shade, crates, etc.
3. Participants are solely responsible for the conduct or actions of their dogs while they are on the trial/testing grounds. All dogs must be kept on leash or in crates except when being tested. Do not approach stock with the dog unless specifically instructed to do so by the Herding Instinct Tester.

**RELEASE/WAIVER AGREEMENT**

In consideration for participation in these events sanctioned by the Belgian Shepherd Dog Club of Canada (BSDCC), I agree to assume all responsibility for any claim, loss or damage, of whatever kind or nature, whether to person or property, which may be caused at or near this event, either directly or indirectly, by me or the dog or dogs I have entered in or brought to this event.
